Environmental Science students are required to develop their understanding of ecosystems, the factors that can impact them and how a range of factors are monitored to contribute to the health of an ecosystem. This knowledge will assist students when they complete the Fieldwork assessment task in Week 9 of Term 1.

Students will investigate aquatic species and ecosystems at the Marine and Freshwater Discovery Centre. Students will investigate the local beach at Queenscliff to demonstrate their understanding of ecosystem monitoring, and then complete a session conducted by the Victorian Fisheries Authority at the Marine and Freshwater Discovery Centre located in Queenscliff. This will provide the students with insights into the interactions between different species in local ecosystems, as well as the impact humans are having on these important aspects of our immediate environment.

- Aim: To complete field surveys and activities conducted by the Marine and Freshwater Discovery Centre for further analysis during class.
- Activities: Students will be reviewing their knowledge of Ecosystem monitoring techniques and completing set activities at the Marine and Freshwater Discovery Centre to further explore local aquatic ecosystems.

the excursion.
